#### **Aviation Maintenance**

The aviation maintenance program at WNCC is approved by the Federal Aviation Administration (FAA). Technical standards for the aviation maintenance program at WNCC are promulgated upon an extensive set of subject-area criteria which cover not only knowledge levels, but also skills demonstration established by the FAA in Subpart D of Part 65 of the Federal Aviation Regulations. The curriculum is specified in Part 147 – Aviation Maintenance Technician Schools.
