

Executive Summary

AS OF THE TENTH DAY OF THE SEMESTER (JANUARY 29, 2022):

- 1. THERE WERE **650 FULL-TIME** AND **904 PART-TIME** STUDENTS. THE TOTAL ENROLLMENT OF **1,554**REPRESENTS A **3.6% INCREASE** COMPARED TO SPRING 2021.
- 2. **FEMALE TO MALE RATIO WAS 60.36% FEMALE TO 39.64% MALE OVERALL** (FULL-TIME RATIO = 56.2% / 43.8% & PART-TIME RATIO = 63.4% / 36.6%). THE WNCC FEMALE TO MALE RATIO IS WITHIN 3% +/- OF MEAN NATIONAL RATIOS AT ALL COMMUNITY COLLEGES.
- 3. HISPANIC ENROLLMENT WAS 377, REPRESENTING 24.3% OF ALL STUDENTS.
- 4. THE END OF SPRING 2022 SEMESTER TOTAL ENROLLMENT IS EXPECTED TO BE 1,636.
- 5. **TOTAL FTE WAS 459.53 WHILE TOTAL REU WAS 612.69.** THE END OF SEMESTER TOTAL FTE IS EXPECTED TO INCREASE AS THE NON-CREDIT ENROLLMENT NUMBERS CONTINUE TO RECOVER FROM THE EFFECTS OF THE COVID-19 PANDEMIC.
- 6. THE WNCC STUDENT BODY HAS STUDENTS **REPRESENTING EACH OF THE COUNTIES WITHIN THE WCCA SERVICE AREA**.
- 7. **HIGH SCHOOL DUAL ENROLLMENT REPRESENTS 34.36% OF WNCC TOTAL ENROLLMENT** (534 TOTAL DUAL ENROLLMENT STUDENTS). THIS IS A 48.33% INCREASE OVER SPRING 2021.












