The review included instructional oversight, academic services, student services, facilities, marketing and recruitment information and adequacy of assessment of student performance. Dr. Hardy's follow up report stated that the pattern of operations at the locations appears to be adequate and no further review or monitoring is necessary.


Chair Klemke declared the Open meeting in session at 11:34 a.m.
