Federal Funding Updates

Dr. Grant Wilson, Vice President of Enrollment Management and Student Services shared information regarding the impact of the "One Big Beautiful Bill" on student financial assistance.

Regarding Pell Grants, the definition of full-time and part-time students did not change. Full-time is still defined as twelve or more credit hours per semester and part-time is still defined as six or more credit hours per semester. The Student Aid Index (SAI) formula has changed, affecting how a student's Pell Grant eligibility is determined. Maximum Pell Grant remains at \$7,395 for the 2025-26 award year. Starting July 1, 2026, Pell eligibility will expand to include certain short-term career and workforce training programs as part of the new Workforce Pell Grant initiative.

On June 30, 2025, the State was informed by the U.S. Department of Education that, due to the change in federal administration, the Department is currently reviewing Fiscal Year (FY) 2025 funding for the Adult Education Basic Grants to States program. As a result of this ongoing review, the Department will not be issuing Grant Award Notifications (GANs) on July 1, 2025, as originally scheduled. Further information will be provided once the review is complete.

Discussions have been ongoing regarding the potential use of up to \$170,000 from cash reserves to sustain Adult Education services through May 2026. This amount may be reduced if certain services are scaled back, and/or the Federal Government releases funds to the states, and the State of Nebraska allocates a portion to us.

As of July 8, 2025, we were awarded the AEC Grant in the amount of \$22,291.20 by the Nebraska Department of Education. These grant funds are sufficient to cover the salary of one position within the Adult Education program.

Federal Funding Updates (cont.)

Some deferment options for unemployment or financial hardship have been eliminated. Borrowers now have two opportunities to use Loan Rehabilitation (previously only one). This allows borrowers to get a defaulted loan back in good standing more than once, offering greater flexibility for those struggling with repayment.

On July 8, 2025, the institution received a Grant Award Notification (GAN) from the U.S. Department of Education for the TRIO Student Support Services (SSS) Program. The award was for the performance period of September 1, 2025 to August 31, 2030, \$416,576 each year.
