Definitions

CAO – Chief Academic Officer

Curricular Activities: All the courses of study offered by an educational institution and/or a group of related courses, often referred to as a program of study. Can include credit or non-credit program offerings.

Nebraska Coordinating Commission for Postsecondary Education (CCPE): Arm of the Nebraska Department of Education responsible for comprehensive planning for postsecondary education in Nebraska.

Rubric: An evaluation tool or set of guidelines used to promote the consistent application of learning expectations, learning objectives, or learning standards in the classroom, program of study or departmental activities to measure their attainment against a consistent set of criteria

Procedure

All curricular programs will complete each year an "Annual Program Review" (Appendix 617A). On a five-year cycle, each program will complete a "Five-Year Program Review" (Appendix 617B) to assess educational programs at greater depth. An approved rubric (Appendix 617C) will be used to assess the program's strengths and weaknesses in order to inform continuous improvement and alignment with the College's mission and strategic plan. Programs will complete the Nebraska Coordinating Commission for Postsecondary Education's (CCPE) *Review of Existing Instructional Programs* form concurrent to the Five-Year Program Review.

Division chairs and faculty who primarily teach the program, or teach courses in the program, will work collaboratively to complete the program review. When complete, the program review will be forwarded to the Program Review Committee for consideration and evaluation. After due

consideration, the committee will recommend to the CAO one of the following regarding the status of the program:

• Continue without modification

- Continue with modification
 - > The Program Review Committee will identify required modification(s).
 - The impact of those modification(s) will be included in the program's next annual or five-year report, whichever is sooner.
 - > If progress toward required modifications is being made, the action may be repeated.
 - If the program being reviewed is a new program, then Board Policy 616 (New Instructional Programs) will be taken into account.

• Move to Program Support

- > The Program Review Committee will identify reasons for recommendation.
- If the CAO agrees with the recommendation of the Program Review Committee, Administrative Policy 617.02 (Curricular Program Support or Program Closure) will be in effect.
- Terminate Program
 - > The Program Review Committee will identify reasons for recommendation.
 - If the CAO agrees with the recommendation of the Program Review Committee, Administrative Policy 617.02 (Curricular Program Support or Program Closure) will be in effect.

The College President, in consultation with the CAO, will make the final decision regarding program status.

Program Review Committee

The following shall be members of the Program Review Committee:

- A dean of instruction, who will serve as chair
- Two faculty members, in staggered two-year terms, representing each division and as determined by Faculty Assembly.
- Ex-officio members to include the Admissions Director or designee, Registrar or designee, and the Accreditation & Special Projects Director

Timeline

The Curricular Program Review Procedure (AP-617.01) and Appendix D (Program Review Cycle) will be reviewed in September of each year by the Program Review Committee to ensure all

are up to date and that the five-year cycle of program review is adhered to or modified to meet emerging or unique needs of a program.

The recommendations of the Program Review Committee will be forwarded to Faculty Assembly for comment. Program Review Committee recommendations will then be forwarded for review and action by Academic Council prior to final submission to the CAO by April 1 of each year.

The CAO is responsible for ensuring that all academic program reviews are completed within a timeline corresponding to the requirements of the Nebraska Coordinating Commission for Postsecondary Education (CCPE). The CAO will ensure that any program review to be forwarded to the CCPE is submitted to the WCCA Board of Governors for final review and subsequently to the CCPE by no later than June 1.

Exceptions to the Procedure

This process can be expedited or move straight to consideration of program elimination and therefore reduction-in-force policies in the case of financial exigency or other extreme circumstances as identified by the President and Board of Governors.
