- Financial need as determined by the 2020-2021 Free Application for Federal Student Aid (FAFSA)
- You must be in an eligible degree, certificate, or diploma program
- You must be making satisfactory academic progress
- You may not be in default on a federal student loan or owe repayment of a federal grant
- You must have a high school diploma or GED
- You must be a U.S. citizen or eligible non-citizen
- You must have a valid Social Security Number
- You must be registered with Selective Service, if required
